1. Organizational Restructuring

Effective April 1, 2024

Corporate departmental organizational reforms

- As part of strengthening the systems business portfolio, the IT Development Headquarters will be abolished, and the aG Cloud Development Department will be newly established to create a development system that optimizes a cloud system development within the entire azbil Group.
- With the aim of further strengthening the compliance management system, and to strengthen collaboration between legal department and CSR and risk management department, the Legal and Risk Management Headquarters will be established, under which the Legal Department and the CSR and Risk Management Department will be assigned.

Building Systems Company's organizational reforms

- In order to shift focus to cloud app (including GX app) development, the Environmental Marketing Department in the BSC Marketing Headquarters will be abolished and each function will be relocated within the Company.
- The functions of the Instrumentation Sales Departments 1 and 2 in the BSC Kansai Regional Division will be reorganized and renamed to the Instrumentation Sales Department.
- The name of the Instrumentation and Sales Planning Department in the BSC Instrumentation Headquarters will be changed to the Instrumentation Planning Department.

Advanced Automation Company's organizational reforms

- The following organizational changes will be made with the aim of strengthening product competitiveness and strengthening business capabilities of the Advanced Automation business.
- The Strategic Business Development Department 2 (for valve business) will be established as a new business development department to promote spiral business development.
- The Strategic Business Development Department 3 (for autonomy field) will be established as a new business development department promoting spiral business development, and the current IT Service Promotion Department in the Engineering Headquarters will be abolished.
- The name of the Strategic Products Development Department will be changed to the Strategic Business Development Department 1 as a new business development department that promotes spiral business development.
